Dear Premier

On behalf of Queensland's 296 Catholic school communities we are writing to seek your response to several requests we are making in relation to policy and resourcing for Catholic schools by the next State Government.

We would like to communicate your responses to these requests, along with those of the ALP, to our school communities ahead of the upcoming State election.

It is in the context of fairness and equity for Queensland Catholic schools that we are seeking the following commitments from your LNP government.

1. Annual per student funding that keeps pace with the rising costs of education

Catholic schools in Queensland, on average, receive only about 81% of the government funding per student received by State schools (*MySchool website 2012*).

State government funding for Catholic schools helps relieve pressure on school fees and assists more families to choose a Catholic school. This also relieves pressure on the State school system and saves government money.

Catholic education is seeking to work with the next Queensland Government to achieve consistent budget outcomes that will:

- assist Catholic schools to keep pace with the rising operating costs of education delivery
- ensure that the gap in resourcing between Catholic schools and state schools does not widen.

2. Increased capital funding to deliver the additional student places required to meet the needs of Queensland's growing population

Demand for places in Queensland Catholic schools is projected to increase by around 60,000 students between 2011 and 2031. This will require the development of 2-3 new schools every year and the expansion of many others.

The Catholic sector cannot keep pace with this level of growth under current capital funding arrangements.

If Catholic education authorities are unable to cater, at least for existing market share, and students need to be accommodated in State schools, this will cost government significant amounts of money in both capital and recurrent cost of education.

Catholic education is therefore seeking a commitment from the next Queensland Government to:

- work in partnership to help deliver the school infrastructure required
- provide a capital grants program that reflects the real cost of delivering the required additional school places. Queensland Schools Planning Commission projections calculate that Catholic education will need to deliver an additional 60,000 places by 2031. QCEC estimates this will require an additional \$49 million per year in State government funding over the 20 year period to deliver the 36,000 places required in new schools. Current State capital funding streams of \$43m per annum will need to be maintained to expand existing schools by 24,000 places.

3. Students With Disability (SWD)

The number of students with disability attending Catholic schools in Queensland increased by 92% between 2008 and 2013 meaning that most teachers in Catholic schools have a number of students in their classes for whom educational adjustments and support are required.

Catholic education is seeking a commitment from the next Queensland Government to:

- include the Catholic sector in trials of 'tele-health' modes to deliver health screening services to regional and remote students
- assist Catholic schools to access support and advice from DETE or other specialist staff on a fee for service basis
- deliver a collaborative approach to professional development for SWD teachers across sectors, making it more viable to deliver
- develop a mechanism for cross-sectoral collaboration to prepare for the implementation of the NDIS.

4. Vocational Education and Training (VET) for secondary school students

Catholic education strongly believes that VET must play a central role in the provision of pathways for students, and in doing so, help build a highly skilled workforce and contribute to keeping the Queensland economy strong.

Catholic education is seeking policy and funding reform from the next Queensland Government to:

- increase student access to VET programs in regional and rural settings
- expand the list of qualifications funded in the 'Employment Stream' to provide greater breadth of pathways for girls to transition to post-school training and employment outcomes
- more appropriately assist schools that are delivering higher cost VET courses
- provide targeted or seed funding to schools to develop additional career development programs.

5. Parent Engagement Strategies

Catholic education is seeking a commitment from the next Queensland Government to:

- work collaboratively to support strategies to enhance parent engagement across all Queensland schools
- provide \$250,000 in funding to enable the Catholic sector to roll out its recently developed framework for parent engagement, including a bank of resources and standards that enable schools to measure their success
- collaboratively devise and support a program of research and planning to further connect schools and playgroups and assist parents with the necessary tools in the vital first three years.

Premier, we are greatly appreciative of both your personal support and the support of Minister John Paul Langbroek and the LNP Government for Queensland's Catholic school communities.


We look forward to the LNP's response to the requests outlined in this letter.

Further, we also recognise your Government's commitment to the education of young Queenslanders and would welcome any opportunities to collaborate with the LNP on policy development.


